EXPRESSION OF INTEREST **(EoI)**

Kerala SRTC is inviting **"EXPRESSION OF INTEREST" (EoI)** from the reputed manufacturer / authorized dealers, who have experience in supply and commissioning of **"Floor Scrubbing Machine"** suitable for Automobile Workshops and Garages of KSRTC.

1. Introduction

KSRTC has a fleet strength of around 5500 buses with our head office located at Transport Bhavan, Fort, Thiruvananthpuram. KSRTC has 22 district workshops and 92 depot / sub depot / operating centers.

2. Scope of Work

- a. This EoI invited for fixing the specification of Floor scrubbing machine suitable for Workshops and Garages of KSRTC.
- b. Floor scrubbing machine shall be suitable for scrubbing the hard greasy surface in the floor of Automobile Workshops and Garages.
- c. The Floor Scrubbing Machine shall be Battery powered.

3. Pre Qualification Criteria

- a) The manufactures / Authorized dealers of Floor Scrubbing Machine can only participate.
- b) The details of Guarantee/Make / Brand / specification of offered item / Brochure etc should be provided.
- c) The documents to prove that the bidders are either the manufacturer or their authorised distributor of the item should be submitted.
- d) Details of supply and installation of similar machinery done at any Govt. / Private Institutions / State Transport Undertakings

4. EoI documents should cover the following

- a. The bidder shall be manufacturer / authorized dealer.
- b. The details of Guarantee/Make / Brand / specification of offered item / Brochure etc should be uploaded.
- c. Specification of Floor Scrubbing machine shall be specified
- d. The bidder should have a proven track record of successful supply, installation, testing and commissioning of Floor Scrubbing Machine for the last 3 years.
- e. Letters reference from past customers along with contact address, phone / mobile No., e-mail ID etc of each customer should be provided in order to show past performance in the execution of projects of a comparable nature and complicity.
- f. The warranty / AMC details should be specified.
- g. The other information useful to KSRTC may also be provided.
- h. This EoI (all pages) duly filled, signed and stamped by the bidder in each page should be scanned and uploaded.
- i. Scanned copy of bidder's information in ANNEXURE-A after filling all the columns and duly signed and stamped by the bidder should be uploaded.

- j. Tenderers who have been blacklisted by the Tender Inviting Authority or by any State Govt. or Central Government / Organization should not participate in the tenders during the period of blacklisting. An affidavit as per format in Annexure-B (Anti-Black listing Affidavit) should be submitted along with the technical bid.

5. Stages of Evaluation:

- a. Opening of the EOI.
- b. Technical Evaluation by the Technical committee constituted by KSRTC.

After evaluation of the proposals and the comments received from prospective firms, KSRTC shall prepare the detailed tender document and invite e-tender. It is not necessary that the firms participated in this EOI shall only be eligible to participate in the tender. The decision of Chairman and Managing Director, KSRTC shall be final in this regard.
