1.Scope of the Contract

Auction cum e-Tenders are invited for the display of advertisement in Bus Stations, Bus Shelters and certain specified land of KSRTC Corporation as per Annexure-VI for **ONE YEAR** and extendable for **Four Years** with an escalation of 10% of license fee on completion of every year of the license period, on compounding basis.

Persons / Advertisement Agencies or any other organization can submit their e-Tender for all bus stations in Trivandrum District only and specified land of KSRTC mentioned in the Annexure -VI in lump sum only. Those who submit e-Tender can only participate in the auction.

The intending persons/agencies should ensure themselves before submitting their tender about the availability of space for the display of advertisement in each bus stations. The tenderer may also contact all Unit Officers of KSRTC for identifying the site before submitting their tender

1. PRE QUALIFICATION CRITERIA

- a. If the tenderer is a business establishment it, must have a valid registration certificate obtained from the statutory authority
- b. Bidder should have GST Registration.
- c. The bidder should have minimum Annual Turnover of Rs.25 Lakh per year

2. General Conditions of the contract

- a. Bidders should remit the required Tender Fee and Earnest Money Deposit (EMD) in 'Online mode' through SBI/NEFT, as per 1(e) and I(f) of the Notice Inviting Tender. No exemption in the case of EMD and Tender Fee. Bidders should ensure and convince themselves that the online payments made by them have been successfully transferred. KSRTC shall under no circumstances be responsible for failed transaction of the payments due to non-compliance of any online banking procedure and consequent rejection of tender.
- b. Firms who have been blacklisted by the Central Government/ any State Government /any State Transport Undertaking will not be considered.
- c. The tenderer should quote the license fee for one Year.

- d. Auction cum e-Tender invited is for all bus stations of KSRTC Trivandrum District. In Thampanoor (TVM Central) Bus station the hoardings may be placed in the four stands that have been pre-fixed and these stands shall not be shifted by the licensee. Therefore, Persons / Advertising Agencies / Organisations shall quote amounts for all bus stations (mentioned in Annexure VI) in lump sum only. Persons / Advertising Agencies / Organisations who have submitted e-Tenders are only eligible for participating in the auction. e-Tender for a part / region of bus stations will not be accepted.
- e. Normally license will be awarded to the tenderer who quotes the highest amount in auction or tender. Corporation reserves the right to use in any manner 10% of the available space as identified by Corporation in each Bus Station, Bus Shelters other than the space allotted to the licensee for the display of advertisement / information.
- f. The decision of the Chairman & Managing Director on all matters arising out of this Notice / Contract will be final, conclusive and legally binding on all parties concerned.
- g. Opening of E-Tender will be done at the time and date noted in the e- tender portal at the Office of the Chairman and Managing Director, KSRTC.
- h. Bidders who have been blacklisted by the Tender Inviting Authority or by any State Govt. or Central Government / Organization should not participate in the tenders during the period of blacklisting. An affidavit as per format in Annexure- V (Anti-Blacklisting Affidavit) should be submitted along with the technical bid.

3. MODE OF SUBMITTING TENDERS

1. Tender documents shall be submitted through e-Tender. One for **Pre-Qualification Bid** and the other for **Price Bid**.
2. The tenderer shall submit the tender documents as specified hereunder.

2. Round 2 – Document evaluation:-

The terms and documents submitted as part of the bids shall be scrutinized by the Tender Inviting Authority.

The Tender Inviting Authority may call for additional documents/clarifications through e-tender portal.

The list of those who come out successfully of the evaluation of the documents as well as those rejected (with reasons for rejections) will be published on the website of KSRTC (www.keralartc.com) and objections/remarks against the list will be invited. The objections /remarks received before the date and time specified in the notice will be considered by the Tender Inviting Authority and the final list of successful bidders of

7. Opening of Price Bid: -

- a. The PRICE Bid of those bidders, who satisfied all of the Prequalification Criteria shall only be opened for further consideration. The PRICE BID of those bidders who do not satisfy even any one of the pre-qualification condition will not be opened.
- b. Opening of e-Tender will be done at the time and date noted in the e-Tender portal at the Office of the Chairman and Managing Director, KSRTC
- c. The bidders have the liberty to resubmit fresh tender/documents till the last date and time of submission of the e-tender.
- d. Resubmission of offer will not be allowed after the time and date fixed for bid submission. The offer once made cannot be withdrawn or modified after the closing of e-tender under any circumstances. Withdrawal or modification of the offer once made in e-Tender will be resulted in the forfeiture of EMD remitted. In such cases the bidder will not have the right to claim the refund of EMD.
- e. The Chairman and Managing Director KSRTC reserve the right to make any modifications or additions in this notice in the event if it is felt that it is in the public interest.

- b) Firms who are not blacklisted by KSRTC or by Govt. of Kerala can participate in the tender.

If the e-Tender opening date happens to be a holiday or non-working day due to any valid reason, the Tender opening process will be done on the next working day at the same time and place specified. - j. Bidders are advised to go through all conditions of the Notice Inviting Tender and the Tender documents carefully and to comply them to avoid rejection of their tender.
- h. Furnishing of any false information / fabricated document would lead to rejection of the tender at any stage.
- i. The bidder shall bear all costs associated with the preparation and submission of its bid and Kerala State Road Transport Corporation, Thiruvananthapuram, hereinafter referred to as "Tender Inviting Authority", will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

e-TENDER CONDITIONS FOR THE ALLOTMENT OF SPACE FOR THE DISPLAY OF ADVERTISEMENT IN KSRTC BUS STATIONS, SHELTERS BY INSTALLING STATIC HOARDINGS AND ELECTRONIC HOARDINGS / SCREENS FOR ONE YEAR EXTENDABLE UPTO FOUR YEARS.

e-Tenders are invited from individuals and interested firms for entering contract for the display of advertisements in KSRTC Bus Stations and Bus Shelters / Land (details of Bus Stations annexed separately) of One Year extendable up to Four Years subject to the terms & Conditions mentioned here under with an escalation of 10% of license fee of completion of every year of license period on compounding basis.

1. The Tender Form containing the tender conditions can be downloaded from the e-Tender site. The cost of tender form shall be paid through e payment. Cost of tender form is not refundable under any circumstances.
1. The Tenderer shall quote the amount towards licence fee for one **Year**.
2. The licence will be confirmed to the Party who quotes the highest amount in the Tender / Auction.
3. The Corporation shall normally accept the highest offer in the auction/ tender but the Corporation reserves the right to accept or reject any of the tenders without assigning any reason whatsoever, if such a step is deemed necessary to safeguard the interest of the Corporation.
4. The tenderer should specify in the tender the experience he possesses and the extent of the present business in the relevant field.
5. The Earnest Money of Rs.50,000/- should be remitted through e-payment in favour of the Financial Advisor & Chief Accounts Officer, KSRTC Corporation, Transport Bhavan, Thiruvananthapuram.
6. If any tenderer withdraws his tender on or after the specified/prescribed time for opening Tender/Auction, the EMD shall be forfeited forthwith. Withdrawal of tender by the successful tenderer will entail forfeiture of EMD without further notice. Moreover, the difference in amount between the highest bidder and the second highest bidder will also be realised from the successful tenderer invoking provisions of Kerala Revenue Recovery Act, 1968 as the case may be. The loss sustained due to the withdrawal of successful tenderer will be realised from the tenderer on any manner Corporation may think fit.
7. Three months license fees as security deposit and 6 months license fees + GST to be remitted within 30 days from the receipt of the provisional confirmation order (Shown in Annexure II).

9. The amount remitted as Security Deposit will be released to the party after the satisfactory completion of contract period without interest. In the event of failure on the part of the licensee to remit the instalments in the manner specified herein, interest @18% per annum for the defaulted days for each monthly instalment shall be realised (*i.e. interest will be calculated from the 1st day of the respective month*). Default of any monthly instalment beyond sixty days shall not be allowed under any circumstances and the Corporation reserves the right to cancel the contract in such cases, without prior notice. The licensee is liable to compensate the Corporation the loss, if any, so sustained.
10. The successful tenderer shall be required to execute an Agreement (Licence Deed) in stamped paper worth Rs.200/- (Rs. Two Hundred only) as per the draft prescribed by the Corporation embodying the conditions specified herein and such other terms and conditions as may be decided from time to time if found necessary.
11. The electoral ID card & Aadhar card number of the licensee and witnesses has to be entered in the agreement and its self attested copy should be made part of Agreement.
12. In the case of failure of the successful tenderer to fulfill the conditions herein stated, before the commencement of the contract or to remit the payment of the monthly instalments on the due dates or to abide by the terms and conditions of the agreement, the Chairman & Managing Director will have the right to cancel the contract and to award the contract to another contractor or to carry out the work by the Corporation as Corporation deems it fit and any amount paid by the licensee to the Corporation will be forfeited. Besides the licensee shall be liable for any loss caused to the Corporation by reason of cancelling the contract. The amount due to the Corporation shall be realised under provisions of Revenue Recovery Act as arrears of land revenue or under the provisions of law in force from any amount due to the licensee on any account or in any other manner as the Corporation may deem fit.
13. No representation for the reduction of rates once accepted will be entertained under any circumstances.
14. The Corporation shall have the power to cancel the contract entered into with the licensee with one-month notice, if it considers that such cancellation is necessary in the interest of the Corporation / general public. The licensee shall abide by such decision of the corporation.
15. The licensee shall be liable to pay advertisement fee, taxes or any other amount levied by the Government, local or other authorities from time to time. The licensee shall remit GST if any, along with each payment. If the licensee fails to remit these statutory levies / taxes, the particular amount

with interest, penalty imposed by Government / local bodies (i.e. taxes and levies etc.) will be realised from the amount remitted by the licensee towards security deposit. If such liability exceeds the Security Deposit, it will be realised under the provision of Kerala Revenue Recovery Act or any other law then in force in respect of present as well as future claims.

16. The security amount will be refunded to the licensee after the expiry of the licence period and after the successful completion of the contract period and upon clearance of advertisement taxes, statutory levies etc., if any, due to Government or local bodies, as well as after deducting liability if any.
17. If the licensee retracts from the fulfilment of the contract without valid reason, he shall be liable to compensate the loss, if any, sustained to Corporation on account of this. The loss so sustained will be realised from the defaulter invoking provisions of Revenue Recovery act or by invoking provisions of any other law.
18. No space shall be let out to the licensee for the display of advertisements beyond the date of expiry of contract.
19. Fixing, painting and removing of advertisements shall be done by the licensee at his own risk and cost. He shall not be allowed to drill holes in the constructions and fittings of bus stations and Bus Shelters. The work of fixing and painting of advertisements must be carried out in such a way that it shall neither make hindrance to service operations and other establishments in the bus station premises, nor the beauty of the Bus stations and Bus shelters are affected. As far as possible the works relating to advertisement shall be carried out preferably during night time. While erecting and maintaining the advertisement materials, the licensee shall ensure the safety and security of the general public and employees and with the movable and immovable properties of KSRTC.
20. Advertisements which offend any law or hurt religious feelings of people or against public policy, morality or defamatory or the display of which is prohibited by any lawful authority, shall not be displayed by the licensee in the Bus Stations and Bus Shelters of the Corporation. The Corporation reserves the right to refuse the display of any advertisements. The licensee shall not be allowed to display advertisement in Bus station Buildings without prior sanction.
21. Display of advertisements will not be allowed in any Bus stations or Bus Shelters other than the ones allotted.
22. The licensee shall furnish attested copy/copies of all permit/licence issued by the local authority concerned in respect of the hoarding/hoardings erected, to the KSRTC every year. The tariff related to KSRTC office, garage are LT6B and LT4A respectively. But tariff related to

- advertisement (display lighting, hoarding, external illumination of building) is LT 9. Hence the licensee should take separate electricity connection in LT 9 tariff for advertisement purposes.
23. The licensee shall display advertisements only in the hoarding erected by him authorising and maintained by him statutorily and it is mandatory to display his Licence number in every hoardings.
 24. The licensee has interest only in respect of the hoardings erected by him and is authorised to display his advertisements only in the hoarding erected by him and any hoarding erected by any other person or Corporation does not create any interest or right on him and he has no authority to display the advertisement in the said hoardings and any understanding, undertaking or assigning of license to display the advertisement in such hoardings erected by the said person is invalid and is not binding to the Corporation.
 25. The Corporation reserves the right to exhibit any Advertisement of KSRTC or any advertisement sponsored by the Corporation in its Bus stations and Bus shelters subject to the condition that such Advertisement does not occupy more than 10% of space available. The Corporation will also be at liberty to utilize any space not included in the licence for any purpose, if desires so.
 26. The licensee shall procure separate electricity connection at his own cost for the operation / maintenance of the advertisement system and shall pay the monthly charges. Corporation may provide electricity for the operation / maintenance of the advertisement System after installing separate electric meter by the licensee at his own cost and shall remit the electricity charges for the electrical energy consumed, if permitted by the authorities. The audio frequency of advertisements shall be as per the norms fixed by Government / local bodies from time to time and shall not cause any disturbances to the functioning of the office / public.
 27. The wiring, mainly by multicore cables should be well protected and insulated against all disturbances so as to sufficiently ensure safety and to the satisfaction of the concerned statutory authorities. The licensee is bound to produce fitness certificate from the concerned electrical authorities, when required by the Corporation. The licensee shall install separate energy meter at his own cost to measure the electrical energy consumed.
 28. The Chairman & Managing Director, KSRTC has the right to impose penalty / fine, if any, for the violation of any of the conditions mentioned herein.
 29. The licensee shall obtain necessary permit from the concerned Corporation/ Municipality/ Panchayat and erect the hoarding in the earmarked site strictly in accordance with the permit and the time to time Rules and Regulations of the concerned Corporation/Municipality/ Panchayat etc and shall ensure its structural stability every year renewing the permit/license required by the statute without any room for any security hazard.
 30. The licensee shall undertake all responsibilities at his own risk and cost for

- the installation and maintenance of the entire system and shall remove the entire system on expiry of the contract at his own cost.
31. The hoardings erected by the licensee shall be removed within 30 days at his own costs from the date of termination of license or by efflux of time and any hoardings remain unremoved shall vest with the Corporation and the licensee should not have any lien or interest over the same on the withdrawal or termination of license and in case the Corporation is constrained to cut and remove the hoardings, that entire expenditure shall be recovered from the licensee.
 32. If any injury occurs to the public both personally and on ecological grounds, if any, arising out of accidents/mishaps from the hoardings, advertisement boards, the licensee shall undertake all responsibilities at his own risk and cost of damage shall be borne only by the licensee.
 33. The premises of KSRTC where the advertisement is to be exhibited is mentioned in the annexure. The space allotted for the advertisement shall be decided in such a way that there is no hindrance to the service operation or any discomfort to the travellers. The space for advertisement should be decided with prior consent of the unit officer. Number of hoardings erected in the bus station premises should be decided by the corporation. The maximum size of hoardings should be 40'x25'.
 34. If the successful tenderer fails to execute the agreement as instructed in the provisional confirmation order, the Corporation will be at the liberty to confirm the tender in favour of the second highest bidder, if it deems fit and loss on account of this (i.e. difference between the highest and second highest bid amount) will be realised from the defaulted tenderer by invoking provision of Kerala Revenue Recovery Act or any other law then in force.
 35. If the licence is terminated on attaining the agreed period, or otherwise, the licensee will only be responsible to the advertisers. The Corporation has no liability to the advertisers as the contract is only between the Corporation and the Licensee. The licensee shall have no right to assign, sublet or underlet the licence to any others.
 36. Neither KSRTC nor Licensee shall be liable for any inability to fulfil their commitments and obligations hereunder occasioned in whole or in part by Force Majeure, any of the following events resulting in material adverse effect, shall constitute force majeure events:
 - Earthquake, Flood, Inundation, Landslide.
 - Storm, Tempest, Hurricane, Cyclone, Lighting, Thunder or other extreme atmospheric Disturbances.
 - Fire caused by reasons not attributable to the Licensor. Acts of terrorism.
 - War, hostilities (whether war be declared or not), invasion, act of foreign enemy, rebellion, riots, weapon conflict or military action or civil war.

- Strikes or boycotts, other than those involving the Licensor, its contractors, or their employees, agents etc, and
 - Any other similar things beyond the control of the party, except court order/ court judgment.
37. The decision of the Managing Director on all matters arising out of the agreement will be final, conclusive and legally binding on all parties concerned. The Chairman & Managing Director reserves the right to cancel the quotation without showing any reason.
38. Disputes if any, arising out of this agreement shall be settled within the jurisdiction of Courts at Thiruvananthapuram.
