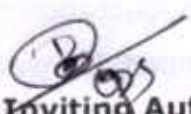
1. The bidder shall submit 2 sheets of A4 size sample paper (each colour) as per specification along with tender documents.

6. Quantity variation shall be plus or minus 15% as per Kerala Store Purchase Manual.

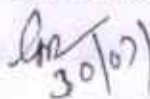
