Bidder, if himself/herself visits the site for inspection, must carry his/her Photo ID Card along with the GST registration card. In case inspection is made by bidders representatives then they should carry with them proper authorisation of their Identity and Signature on bidders letter head under bidders signature along with certified bidders GST registration and Adhaar Card.

Bidder must satisfy themselves about the nature, quality, quantity, physical conditions, technical specifications, taxes-duties and other legalities of the materials prior to submission of bid. Discrepancy if any found may be brought to the notice of Seller at least 3 days prior to the auction start date. Submission of bid would lead to draw a presumption that Bidder has inspected the material physically and thoroughly and has satisfied himself with respect to all aspects. No complaint, whatsoever, with respect to any aspects of the material would be entertained after submission of the bid.

Bidder shall inspect the material physically and thoroughly to satisfy themselves about the nature, quality, quantity and other properties, if any, before submitting the bid. Seller will not be responsible for any complaint in this regard.

7. Scrap Stocks are free and clear of any and all encumbrances.

9. PRE -QUALIFICATION CRITERIA

- a. If the tenderer is a business establishment, it must have a valid registration certificate obtained from the statutory authority
- b. Bidder should have GST Registration.
- c. The bidder should have minimum Average Annual Turnover of Rs.10,00,000/- (Rupees Ten Lakh) per year for the last three financial years commencing from 2021-22.
- d. The bidder should submit an affidavit for not facing Court case/ Criminal case/ revenue Recovery against KSRTC.

10. **Documents to be uploaded in the e-tender Portal**

1. Authoritative documental proof of Firms/ Proprietorship/ Company/Individual. Valid document shall be uploaded.
2. Attested copy of voter ID card / Aadhaar.
3. Details of experience, in the Scrap item field.

5. Copy of self attested authoritative documents to prove the identity of proprietorship /partnership /entity /company / individual.
6. Authorization Certificate to participate in the tender as per Annexure IV, wherever applicable.
7. All pages of NIT and Annexures duly signed and stamped by the bidder.

9. Annual Turnover Statement (Annexure II) duly filled and signed by the Auditor.
10. Format for Affidavit certifying that Entity / Promoter(s) / Director(s) / Partners of Entity are not blacklisted / Defaulter / Involved in litigations (Annexure-III).

11. General Conditions of the contract

- a. Bidders should remit the required Tender Fee and Earnest Money Deposit (EMD) in Online mode through SBI/NEFT, as per 1(d), 1(e) and I(f) of the Notice Inviting Tender. No exemption in the case of EMD and Tender Fee. Bidders should ensure and convince themselves that the online payments made by them have been successfully transferred. KSRTC shall under no circumstances be responsible for failed transaction of the payments due to non-compliance of any online banking procedure and consequent rejection of tender.

- b. First Payment Instalment

H1 Bidder will have to remit 25% of material value mentioned in tender details. First payment instalment is to be made strictly in accordance with terms & conditions stated in NIT with respect to Time-Period and Rate Percentage or as indicated in Sale Intimation Letter.

The EMD will be adjustable towards material value only after receipt of the balance material value of last instalment (in case of instalment payment) along with applicable Duties & Taxes as per terms and conditions of e-auctions failing which the EMD will stand forfeited automatically.

Non receipt of first payment instalment within the stipulated time period will lead disqualification of Sale. Late remittance of payment under any circumstances will not be entertained

- c. The tenderer should quote the bid value per Tyre basis for tyres and per kg basis for other items.
- d. Sale will be awarded to the tenderer who quotes the **highest amount in e-auction or tender**. The decision of the Chairman & Managing Director, KSRTC on all matters arising out of this Tender Notice / Contract will be final, conclusive and legally binding on all parties concerned.

- e. Opening of E-Tender will be done at the time and date noted in the e-tender portal at the Office of the Chairman and Managing Director, KSRTC, Transport bhavan, Fort, Thiruvananthapuram.
- f. Firms /Proprietors who have been blacklisted by the Tender inviting Authority/ Central Government/ any State Government /any State Transport Undertaking will be considered disqualified for participating in the tender during the period of blacklisting. An affidavit as per format in Annexure V (Anti-Blacklisting Affidavit) should be submitted along with the technical bid.

12. Instructions for quoting Financial bid :-

- a. The bidder should quote the basic rate for 1 No. of Scrap Tyre for each type tyre separately, and rate for 1 No. of Scrap Tubes, 1 No. of scrap flaps, 1 No. of scrap curing envelope, 1 No. of scrap curing bag, 1 kg of scrap glass rubber beading, 1MT of Scrap Buffing Powder, 1 kg of Scrap Tread Rubber cut pieces, 1 MT of Scrap cut pieces of Tube and Flap separately in the BoQ. The rates shall be submitted in BOQ portion of the corresponding Tender published in website www.etenders.kerala.gov.in
- b. **The rate quoted should be exclusive of all other incidental expenses lifting and transporting scrap items from KSRTC, Central Works, Pappanamcode, Thiruvananthapuram (Dist.) – 695018), Regional Workshop, Aluva, Regional Workshop, Edapal.**
- c. Material Value in Rupees should be entered in the respective column of BOQ.
- d. Statuary Requirements if any required, shall be borne by the Buyer.
- e. The quantity of item may increase or decrease. The tolerance limit shall not be more than plus / minus Thirty percent ($\pm 30\%$) .

13. TENDER PROCESS:

The tender evaluation will be undertaken in four rounds.

Round 1 - Opening of technical bid documents

Round 2 - Document evaluation.

Round 3 - Opening of price bid

Round 4 - e-Auction

13.1. Round 1- Opening of Pre-Qualification bid documents

The documents uploaded shall be opened at the time and date mentioned.

13. 2. Round 2 Document evaluation:-

The terms and documents uploaded as part of the bids shall be scrutinised by the Tender Inviting Authority. The Tender Inviting Authority may call for additional documents/clarifications through e-tender portal. The list of those who come out successfully of the evaluation of the documents as well as those rejected (with reasons for rejections) will be published on the website of KSRTC (www.keralartc.com), and objections/remarks against the list will be invited. The objections/ remarks received before the date and time specified in the notice will be considered by the Tender Inviting Authority and the final list of successful bidders of round 2 will be published.

13.3. Round 3 : Opening of price bid

- a. The PRICE BID of those bidders, who satisfied all of the Prequalification Criteria, shall only be opened for further consideration. The PRICE BID of those bidders who do not satisfy even any one of the pre-qualification condition will not be opened.
- b. Opening of e-Tender will be done at the time and date noted in the e-Tender portal at the Office of the Chairman and Managing Director, KSRTC.
- c. The bidders have the liberty to resubmit fresh tender/documents till the last date and time of submission of the e-tender.
- d. Resubmission of offer will not be allowed after the time and date fixed for bid submission. The offer once made cannot be withdrawn or modified after the closing of e-tender under any circumstances. Withdrawal or modification of the offer once made in e-Tender will be resulted in the forfeiture of EMD remitted. In such cases the bidder will not have the right to claim the refund of EMD.
- e. The Chairman and Managing Director KSRTC reserve the right to make any modifications or additions in this notice in the event if it is felt that it is in the public interest.

13.4 Round 4 : E Auction

In the e-Auction process, the bidder shall quote the **end rate (Basic rate + GST) per unit of each item** instead of basic rate. The tender will be awarded on the basis of the highest rate with GST quoted in the e-auction, if the Corporation get the expected cost per item in the e-auction. 14 .GENERAL TERMS AND CONDITIONS

- a. The Tender Form containing the tender conditions can be downloaded from the e-Tender site. The cost of tender form shall be paid through e-payment. Cost of the tender form is not refundable under any circumstances.
- b. The Tenderer shall quote the basic rate for 1 No. of Scrap Tyre for each type tyre separately, and rate for 1 No. of Scrap Tubes, 1 No. of scrap flaps, 1 No. of scrap curing envelope, 1 No. of scrap curing bag, 1 kg of scrap glass rubber beading, 1 MT of Buffing Powder, 1 kg of Tread Rubber cut pieces, 1 MT of scrap cut pieces of Tube and Flap separately in the BoQ.
- c. The sale will be confirmed to the Party who quotes the highest rate in the e-Tender cum Auction.
- d. KSRTC shall normally accept the highest offered rate in the e-Tender cum Auction but KSRTC reserves the right to accept or reject any of the tenders without assigning any reason whatsoever, if such a step is deemed necessary to safeguard the interest of KSRTC.
- e. The Earnest Money Deposit should be remitted through e-Tender portal.
- f. If any tenderer withdraws his tender on or after the specified/prescribed time for opening Tender/Auction, the EMD shall be forfeited forthwith. Withdrawal of tender by the successful tenderer will entail forfeiture of EMD without further notice. Moreover, the difference in amount between the highest bidder and the second highest bidder will also be realised from the successful tenderer invoking provisions of Kerala Revenue Recovery Act, 1968 as the case may be. The loss sustained due to the withdrawal of a successful

tenderer will be realised from the tenderer in any manner KSRTC may think fit.

- g. First Instalment payment (25% of Material value) should be remitted with in 7 days from the date of Sale intimation letter from KSRTC and Balance Amount including all taxes to be remitted within 14 days from the date of the sale confirmation letter. If the party fails to remit the Balance amount within the time limit, the sale confirmation letter will be cancelled without further notice.
- h. No representation for the reduction of rates once accepted will be entertained under any circumstances.
- i. Neither KSRTC nor buyer shall be liable for any inability to fulfil their commitments and obligations hereunder occasioned in whole or in part by Force Majeure, any of the following events resulting in material adverse effect, shall constitute force majeure events:
 - Earthquake, Flood, Inundation, Landslide.
 - Storm, Tempest, Hurricane, Cyclone, Lighting, Thunder or other extreme atmospheric Disturbances.
 - Fire caused by reasons not attributable to the buyer. Acts of terrorism.
 - War, hostilities (whether war be declared or not), invasion, act of foreign enemy, rebellion, riots, weapon conflict or military action or civil war.
 - Strikes or boycotts, other than those involving the buyer, their contractors, or their employees, agents etc, and
 - Any other similar things beyond the control of the party, except court order/ court judgment.
- j. Any dispute/complaint arising out of this tender will be addressed in writing to the Executive Director Technical, KSRTC. The decision of the Chairman & Managing Director of KSRTC on all matters arising out of the agreement will be final, conclusive and legally binding on all parties concerned. The Chairman & Managing Director reserves the right to cancel the tender without showing any reason.
- k. Disputes if any shall be settled through mediation and the Corporation will notify mediating official from time to time and only when mediation is failed, litigation within the jurisdiction of the courts at Thiruvananthapuram and Ernakulam need to be sought.

15. Sale will be awarded to the H1 bidder in e-Tender cum e-Auction only if the Corporation get the expected cost per number of each type tyre and expected cost per kg / MT of other items.

16. Steps after Sale awarded

16. a. **Sale intimation Letter** will be sent by KSRTC via e-mail to the Successful bidder mentioning the First instalment to pay with in 7 days it will be the duty of individual bidder to personally check the status of the lot. Bidder must, therefore keep a watch on their e-mails and keep the same valid and active all the time. No hard copy of the sale intimation/Confirmation Letter for items will be issued by KSRTC.
- 16.b. **Sale Confirmation letter** will be sent by KSRTC to buyer on receipt of First instalment, mentioning Balance Amount to Pay with in 14 days.
- 16.c. **Payment of Balance Sale Value for Issuance of Delivery Order:** Delivery Order will be issued by KSRTC on receipt of balance sale value along with taxes and duties indicating details like delivery schedule, payment details etc mentioned in sale confirmation letter. Payment of balance amount will be made strictly in accordance with terms and conditions defined in the e-auction with respect to time period, mode and manner of payment or as indicated in sale confirmation letter. The delivery order will be forwarded to the registered emails of buyer as well as the concerned Workshop head and no physical copy of delivery order will be sent.
- 16.d. Payment Time Period for making payment of Balance amount along with duties and taxes will be full Payment. Time for the purpose of making payment will start from the date of closing of auction excluding the date of auction. Total Free Time Period will not change under any circumstances.
- 16.e. Default in Payment of Balance Payment: For default in making payment of balance sale value along with taxes and duties beyond free time period, a late payment charge (plus applicable GST) at a fixed rate percentage per week or part thereof for a maximum period of 14 calendar days shall be levied extra as per terms of the auction. Late payment charge shall be calculated on basic material value of Auction. However, this shall not confer any right to the Bidder to make any Late Payment of Balance Sale Value or applicable Duties and Taxes. KSRTC

reserves the right to accept or not to accept the payment of the Balance Sale Value with or without the Late Payment charges after the expiry of the stipulated payment time period as mentioned in the auction terms. If the last date of payment happens to be Bank Holiday or KSRTC Holiday, the payment will be accepted on the next working day without late payment charge. Non submission of balance amount and applicable Duties and Taxes will lead to forfeiture of EMD and First instalment.

17. Delivery Details

1. Delivery Order: On receipt of the payment towards Balance Amount along with taxes and duties, delivery order will be issued indicating the last date of free lifting (60 days from the date of Sale confirmation letter).
